Please note that the wristband does not cover purchase of any food/drink item or confetti eggs. Game wristbands will be available for pick up at the Carnival.

**Oak Hill Supporter** .....\$50-\$249

**Soaring Eagle** (Includes 2 food and game wristbands) .....\$250 +

**Business Nest**.....\$400 +

The suggested contribution level for businesses wishing to sponsor a booth at the carnival. As a token of appreciation, your business will receive 2 carnival "game and food" wristbands (valued at \$35 each), a sign in front of your sponsored carnival booth with a place for business cards and prominent listing in the PTA newsletter and on the PTA website.

**Sky High Club**.....\$1,000 and above

The suggested contribution level for local businesses and corporations that want to support Oak Hill Elementary School. Those who contribute at this level will receive 2 carnival "game and food" wristbands (valued at \$35 each), a premiere listing on a prominently displayed banner at the school for one year, special recognition on the school marquee for 1 week, premiere listing in the Oak PTA newsletter and on the PTA website.
